

**ORDINANCE NO. 83
CITY OF EMMONS, COUNTY OF FREEBORN
STATE OF MINNESOTA**

AN ORDINANCE ADOPTING A SCHEDULE OF FEES AND CHARGES FOR VARIOUS SERVICES, LICENSES AND PERMITS FOR THE CITY OF EMMONS, MINNESOTA

WHEREAS, the City Council of the City of Emmons has adopted the Minnesota Basic Code of Ordinances as it has been amended and supplemented to be its city code and that code permits the city to adopt by ordinance a schedule of fees and charges for various services, licenses and permits,

THEREFORE, THE CITY COUNCIL OF THE CITY OF EMMONS, MINNESOTA ORDAINS:

SECTION I. PURPOSE

The purpose of this ordinance is to establish a uniform schedule of fees and charges for municipal services, licenses, and permits provided by the City of Emmons, in accordance with the authority granted under Minnesota Statutes and the Minnesota Basic Code of Ordinances (MBC), Appendix IV.

SECTION II. AUTHORITY

This ordinance is adopted pursuant to the authority granted under M.S. § 412.221, subd. 32, and consistent with the provisions of the Minnesota Basic Code, Appendix IV, which permits cities to adopt fees by ordinance for services rendered and regulatory functions performed.

SECTION III. ADOPTION OF FEE SCHEDULE

The City of Emmons hereby adopts the following schedule of fees and charges:


SECTION V. REPEALER

All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.


SECTION VI. EFFECTIVE DATE
